In January 2021, the Corporation received \$1,000,000 through a Covid Relief Fund Agreement with the South Dakota Bureau of Finance and Management (the State). As a beneficiary, the Corporation could use any revenue received to help offset its increased healthcare costs and/or revenue loss and to continue to provide healthcare services. The State set forth guidelines for qualifying costs. During the year ended June 30, 2022, the Corporation incurred qualifying costs for supplies and furnishings, employee related salaries and incentives, and lost revenue totaling \$735,497.

In March 2022, the Corporation received \$1,393,210 through a Section 9817 ARPA Funding Agreement (American Rescue Plan) with the South Dakota Bureau of Finance and Management (the State). As a beneficiary, the Corporation could use any revenue received as a one-time payment to strengthen Medicaid Home and Community Based Services. The funds are to be used for direct care workforce activities (80% maximum) and equipment and supplies (20% maximum). In addition, no more than 55% of the allotted American Rescue Plan funds can be used for one-time compensation adjustments. Funds must be expended by June 30, 2024. The Corporation incurred qualifying costs for direct care workforce activities and equipment and supplies totaling \$72,644 during the year ended June 30, 2022.
